Lengthy Bill of Complaint. The bill of complaint filed today covers many typewritten pages reviewing much of the pust trouble between the clausis and the local church body over the teachings of the pastor and his rmoval by the the paster and his removal by the Attorney Harris E. Galpin, who is acting as counsel for the classis. The bill cites that Rev. Bultema and his followers are holding the church and parsonage illegally, representing themseves as pastor and consistory of the church, when they have been legally deposed. It asks that not only the present pastor and church consistory be made to turn over all the property of the church, but all funds that have been collected since December 16, when the paster was removed. It also asks that the defendants be restrained from interfering in any way with the work of the church, under the temporary consistory.



## COURT REFUSES TO OUST BULTEMA

Judge White Denies Temporary Injunction to Muskegon Classis.

### TRIAL SET FOR JAN. 27

Muskegon, Jan. 8.—Judge Edward White of St. Joseph Thursday denied the Muskegon classis of the Christian Reformed church an injunction restraining Rev. Harry Bultema, deposed paster of First Christian Reformed church here, and his followers, from using the church and the church property. The court based his decision upon

classis, the attorney admitted Thursday morning that opinions in the book clash with church doctrine. He claimed the action of the classis in deposing Mr. Bultema was dismetrically opposed to the standards of the denomination.

Mr. Bultema is supported by the majority of the male members of the church, 162 recently having given him a vote of confidence, while 50 decided against him.

the argument of Mr. Bultema's attorneys that the injunction, if issued, would inconvenience the larger portion of the congregation. The case will be tried before Judge White on Jan. 27 when the court will decide whether the denial of the restraining order shall be made permanent or not. All of the merits of the case which involves the question as to which of the church councils is the ruling body in the Christian Reformed denomination will be gone into.

When the casa began Thursday morning before Judge/White, both sides presented their cases. S. H. Clink, attorney for Mr. Bultema, started his argument in which he intends to show the organization of the Christian Reformed denomination differs from that of others in that it is a federation of churches, varying from the Roman Catholic church in which the bishop has sole jurisdiction of church property.

The decision in the case is expected to rest on the determination of the extent of the authority of the classis. The dispute over which body has the sole. original ruling power in the denomination came up when the attorney representing the classis claimed for that body full juridiction over all ministers and consistories in its district, declaring it is subject only to the general synod, which is the ecclesiastical court having jurisdiction over the whole church. This Mr. Bultema. through his attorney, flatly denied. Though it is said Attorney Clink intends to show that the doctrines set forth by Mr. Bultema in his book "Maranatha," for which the Muskegon classis deprived him of his pastorate in First Christian Reformed church here, are just as much in accordance with the Christian Reformed faith as those of the
